

## **SoftPanel Software License Agreement**

Licensed software (hereinafter referred to as "the Software"): SoftPanel instrument control software for digital power meters, AC power supplies, DC power supplies, DC electronic loads, and AC electronic loads of the models, and other SoftPanel applications for avionics regulations and power efficiency as published on the official website (www.chromaate.com).

This license agreement establishes a mutual agreement between you (the user, including individuals and companies) and **Chroma ATE Inc.** (hereinafter referred to as "the Company") regarding the Software. You should carefully review the terms of this agreement. By using the Software under this license agreement, you agree to be bound by the following terms and conditions.
